Third Party Record Keeper Fees

Some employers and educational institutions have outsourced their employment and degree verification process to a third party company that charges a fee to access the records they maintain.

The following are the fees associated with commonly utilized companies. Approximately 35% of the employment and higher education verifications are conducted through a third party record keeper.

Company	Fee
National Student Clearinghouse	\$ 11.00 (average cost)
TALX (The Work Number)	\$ 14.50 or \$16.50 per verification
